of their listings. At least at first glance. However, upon closer examination, in both of these bibliographies, one can find an entry attributed to Bertram David Wolfe entitled La revolución española de 1936 y la revolución alemana de 1917, published in Barcelona in 1937 by Ediciones Españoles. It is apparent that García Durán, then working in Uruguay under the handicap of inadequate bibliographic tools, had confused 'Wolf Bertram' with Bertram David Wolfe. Cierva and his collaborators, although in Spain, did not take the pains to verify the reference, simply cited García Durán as the source and perpetuated this error. Henceforth, bibliographers should take note that "Wolf Bertram" was the pseudonym of Kurt Landau.

The other instance of bibliographic detection can be found in Reports 66a and 67 respectively, which in actuality is an article prepared for publication for the Revolutionary Workers League. Accompanied by a note dated April 16, 1937 from Barcelona which reads: "Comrades: Print this article at once, but don't write any introduction or change the political text of the document. Any reference to the "role" of the RWL rep. in Spain will be detrimental. P. S. A chicken cackles only after it lays its egg. This is for the editors. H[ugo]." Across the top of the article scrawled in pencil is the following legend "The 6th Anniversary Spanish Republic." The article is signed Hugo [i.e. Hugo Dehler].

Again, neither of the two bibliographies lists this proposed publication under the entry of Hugo Oehler. Only after a concerted search through the bibliographies could an entry be found under the authorship of E. H. Oliver which has the similar title "6th anniversary of the Spanish Republic in Barcelona." Fortunately a copy of this pamphlet was located at the Harvard University Library and a comparison of the texts of both the pamphlet and the article leaves little doubt that outside of minor textual changes, they are one and the same. It is now evident that E. H. Oliver was a pseudonym for Hugo Oehler. For further clarification the title and imprint of the Harvard pamphlet reads: "Eyewitness account, Sixth anniversary of the Spanish Republic in Barcelona by Edward H. Oliver. Chicago, Revolutionary Workers League [1937]."

Considering the amount of incorrect information listed in both bibliographies it now remains doubtful that this pamphlet was ever published by the Generalitat of Catalonia as cited in the bibliographies.

The above are but two instances of the numerous errors found in Spanish Civil War bibliographies and help to point out the need for a more scholarly approach towards work in this field.

The Institute for Early Christian Iberian Studies, College of the Holy Cross, Worcester, Massachusetts Ol610, is the only society in the continental United States which is exclusively concerned with research and investigation in the area of Roman and Visigothic Hispania. The Institute is concerned to put at the disposal of scholars and all interested parties the library facilities, counsel and direction of experts, and research findings of specialists in the Iberian peninsula with special, if not exclusive, emphasis on the period from 50 to 711 A.D. Within this period there are no limitations on the Institute's interests. All questions and areas are considered vital and significant, be they secular or ecclesiastical questions, religious or political institutions and problems, prosopographical or chronological investigations. To date the Institute has gathered a library just short of 1,000 volumes; supported the publication of various monographs, and published the periodical <u>Classical Folia</u> (now in its 26th year). Recently published in the monograph series was: Joseph Szoverffy, <u>Iberian Hymnody</u>: Survey and Problems. In preparation in new English edition is Cristobal Veny, Corpus de las Inscripciones Balearicas hasta la Dominación Arabe.

AMERICAN ASSOCIATION FOR PORTUGUESE AND BRAZILIAN CULTURES

The American Association for Portuguese and Brazilian Cultures was organized in 1970 in Waterbury, Connecticut. history of the lower classes in Madrid, 1885-1914. It deals with working class costs of living, standards of living (including data on nutritional, health, and hygiene problems, both collective and individual), working conditions, class consciousness and labor movements. A large portion of the study is also devoted to the theoretical formation and practical application of ruling class attitudes to the solution of lower class existential dilemmas. This includes examinations of the work and goals of two principal intellectual institutions devoted to analyzing lower class existence, the Royal Academy of Moral and Political Sciences and the Commission and Institute for Social Reforms. The project concludes with an analysis of the social role of the Church and the attitude of the workers toward it. Sources: documents of the two above-named institutions; data collected by the Ayuntamientos of Madrid and Barcelona, the Instituto Nacional de Estadística; medical records. Sources regarding religious activities and attitudes are difficult to find; suggestions would be appreciated. Expected completion date: 1974.

My second project is a study of the reading public in the last third of the 19th century in Madrid. It attempts to correlate salaries, book prices, book circulation, newspaper prices and circulation, and literacy rates. Main focus: the novel (both in book form and folletin) and its reader.

The two projects have drawn financial support from the Danforth Foundation, the Research Foundation of CUNY, and the National Endowment for the Humanities.

REVEALED AUTHORSHIPS AND BIBLIOGRAPHIC NOTES

ON THE SPANISH CIVIL WAR

Victor A. Berch Brandeis University Library

A recent issue of the NEWSLETTER of the SSPHS carried the announcement of the acquisition of the Oehler-Blackwell papers deposited at the Brandeis University Library. Aside from the political and historical aspects contained in these documents, two instances of bibliographical clarification can be gleaned from them.

Report 78, dated April 25, 1937 was sent from Barcelona to the P[olitical] C[ommittee] of the Revolutionary Workers League of America in Chicago. The report concerns itself with the international aspects of the POUM and includes a list of various international figures working on behalf of that organization. The report is unsigned.

A quotation from that report will disclose the following information relevant to one of the published Spanish Civil War pamphlets:

"Landau, who writes as <u>Wolf Bertram</u> and <u>Spectator</u> is in charge of a theoretical bulletin that is soon to appear. He writes articles for them [POUM] and pamphlets. . . "

To determine if any of the pamphlets "Wolf Bertram" may have written about the Spanish Civil War could be located, a check through the National Union Catalogue Pre-1956 Imprints disclosed that "Wolf Bertram" was the author of a pamphlet entitled La revolución española de 1936 y la revolución alemana de 1917-1918, published in Barcelona in 1937 by Editorial Marxista. A copy of the pamphlet is located at the Yale University Library.

Since neither of the two most recent and major Spanish Civil War bibliographies makes any claim to comprehensiveness, 4 it is understandable that the "Wolf Bertram" pamphlet does not appear in either of

DAVID WINGEATE PIKE (Latin American Studies/Contemporary Europe, American College in Paris) has recently published the following: "Aspects nouveaux du role de l'Espagne dans la seconde querre mondiale," Revue d'Histoire Moderne et Contemporaine (Paris, July-September 1972, 510-518; Les Français et la guerre d'Espagne (Paris: Publications de La Sorbonne, 1973), 520 pp., sources include the French Departmental archives of Basses-Pyrénées, Haut-Garonne, Ariège, Aude and Pyrénées-Orientales; in collaboration with José BORRAS, Los de Toulouse (Paris: Ruedo Ibérico) 220 pp., an account, presented party by party, of the political activities of the Spanish exiles in France between 1944 and 1950, based especially in the case of the Spanish Communist Party--on the documentation of the French Departmental Archives. CURRENT RESEARCH INVENTORY

Clara E. LIDA (History, Wesleyan University)

Anarchism and peasant revolts in southern Spain (1873-1883). A study of peasant movements influenced by anarchist doctrines and ideology, during the period of clandestine action by the International Workingmen's Association and the first years of the Spanish Regional Federation of Labor (FTRE). A study of the social and economic conditions of western Andalusia, as well as of the anarchist movement in that region. Special attention will be given to peasant secret societies, their role and activities, organization and membership during those years. Also the relationships and parallels with similar trends in other European countries will be shown. The traditional interpretation of Andalusian anarchism as "millenarian" and "primi tive" will be discussed and challenged. Expected date of completion: 1974-1975. (Related research published to date includes: <u>Anarquismo y revolución en la España del XIX</u> (Madrid: Siglo XXI, 1972); <u>La Mano Negra</u> (Madrid: ZYX, 1972); and "Agrarian Anarchism in Andalusia," IRSH (1969).

Donald C. HENDERSON (Pattee Library, Pennsylvania State University)

Publication of the Columbus Family Papers Inventory: The purpose of this publication is to make known to scholars and other interested investigators the existence of a large and significant manuscript collection dealing with the 18th and 19th century Columbus Family and with a dozen or so other Spanish families dating back to the late 15th century. The documents were brought to this country from Spain about the turn of the century when the scion of a local Pennsylvania family married a relative of a 19th century Columbus descendant, and are still in the possession of that same Pennsylvania family. The collection does not contain any documents concerning Christopher Columbus and his immediate heirs. The other families became associated with the Columbus family through marriage. The collection includes such items as land titles, marriage contracts, religious endowments, financial records, wills, maps, and reports. The authenticity of these papers has been established beyond any doubt. The project, which has been accepted by Pennsylvania State University Press, will include an introductory essay, an inventory of the documents arranged alphabetically by family, and a name/place index. In all the collection consists of some 120 rolls of microfilm (which will be available at the Pennsylvania State University Library) and 165,000 pages of documentation. The project has received financial assistance for the filming of these papers from the Institute of the Arts and Humanistic Studies, Pennsylvania State University. The inventory is a joint endeavor of Dr. Henderson and Dr. Richard L. Garner (History, Pennsylvania State University).
