POSTDOCTORAL FELLOWSHIPS FOR RESEARCH IN SPAIN 1978-1979

Under the Agreement of Friendship and Cooperation between Spain and the United States of America, funds are available for twelve post-doctoral fellowships for research in Spain during the academic year 1978-79. The Joint U.S.-Spanish Committee for Educational and Cultural Affairs, which has been established to administer scholarly exchanges under the agreement, has asked the Council for International Exchange of Scholars to receive applications for the fellowships.

DOWLING'S MEDITERRANEAN III CONFERENCE (BARCELONA) 31 July and 1-2 August 1978

Owing to the academic success of the Mediterranean II Conference at the Royal University of Malta in June, 1976, Professor Norman Holub, Iberian Studies, Dowling College, in collaboration with Professor Pedro Voltes Bou, Department of Economic History, University of Barcelona, is organizing the Mediterranean III Conference in Barcelona, 31 July and 1-2 August 1978. Mediterranean III Barcelona, sponsored by the Institut Municipal d'Historia de Barcelona, Dowling College and the Del Mar Foundation (Washington, D.C.), will emphasize recent research in Iberia and other lands of the Mediterranean basin. "Conflict and Contact in Medieval Iberia: the phenomenon of the Reconquista" was the theme of the Ninth Annual Conference of the Center for Medieval and Renaissance Studies at Ohio State University, 24-25 February 1978. The role of a provincial aristocracy in the years when the Spanish monarchy was attempting to enlist the support of all the provinces in its ambition to regain control of the low countries and to continue to pursue traditional Hapsburg objectives elsewhere in Europe is the theme of this dissertation. This call for cooperation, especially in the matter of furnishing troops, reportedly sparked opposition in the provinces; but, so far the only province studied is Catalonia, which revolted. Nothing is known about the other provinces; this dissertation attempts to fill a small part of that void. Also, this dissertation studies Spanish government from the provincial perspective rather than the traditional view from the center. Finally, this paper hopes to illuminate Mallorca's place in Spanish history. To be completed: June 1978

Hanson, Carl A., "Economy and Society in Baroque Portugal, 1668-1703."

Based on research in Portuguese archives that was funded by the Gulbenkian Foundation, the study first examines the social structure of early modern Portugal and then provides reinterpretation of the suppression of the mercantile class efforts to obtain relief from inquisitional persecution. Examination of changes in the seventeenth century Portuguese mercantilist thought follows. Succeeding chapters focus on the short-lived manufacturing program, colonial and international commerce, especially that in tobacco, and the negotiations leading to the Methuen Treaty. Concluding comments emphasize imperial Portugal's relationship with core-states such as England.

CONSTITUTION OF THE SOCIETY

The Constitution and by-laws are reprinted from the NEWSLETTER, vol. 1, no. 1 (1969), 2-3; and vol. 2, no. 5 (1973), 94.

ARTICLE I

The name of this society shall be Society for Spanish and Portuguese Historical Studies.

ARTICLE II

Its object should be the promotion of historical studies in the field of Spanish and Portuguese history

ARTICLE III

Any person approved by the Executive Committee may become a member by paying \$10.00 and after the first year may continue as a member by paying an annual fee of \$10.00. The Society will accept Student and Associate members upon payment of an annual fee of \$5.00

ARTICLE IV

There shall be an Executive Committee, constituted as follows:

- 1. Seven elected members chosen annually by mail ballot two months prior to the annual meeting of the Society.
- 2. The Committee will elect a Chairman and a Secretary among its members.
- 3. The treasurer and the editor shall be appointed by the Executive Committee. An assistant secretary-treasurer shall be appointed and receive such compensation as the committee may determine.

ARTICLE V

The Executive Committee shall have charge of the general interests of the Association, including the election of members, the calling of meetings, the selection of papers to be read, the publication of a semi-annual newsletter.

ARTICLE VI

This Constitution may be amended at any annual meeting, notice of such amendment having been given at the previous meeting.

BY-LAWS

- I. The Society authorizes the payment of traveling expenses incurred by the members of the Committee attending one meeting of that body a year.
- II. An annual meeting of this Society will be held every year on the third week-end of April.
- III. In case of dissolution of the SSPHS, half the assets shall go to the Library of Congress, and half the assets shall go to the Hispanic Society of America, if that organization is tax exempt under section 501 (c) (3) of the IRS code at the time of dissolution of the SSPHS. If the Hispanic Society is no longer exempt, then all assets shall go to the Library of Congress.
